

New National LGPS Framework for Legal Services goes live.

The Legal Services Framework enables LGPS Funds and Pools to source a variety of legal services matched to their own requirements, from small one-off pieces of work to longer term, single provider arrangements. The Framework is split into 7 different Lots:

- Lot 1: Full Service (England and Wales)
- Lot 2: Full Service (Scotland)
- Lot 3: Full Service (Northern Ireland)
- Lot 4: Investment (UK Wide)
- Lot 5: Benefit Administration, Employer Bodies and Governance (England and Wales)
- Lot 6: Benefit Administration, Employer Bodies and Governance (Scotland)
- Lot 7: Benefit Administration, Employer Bodies and Governance (Northern Ireland)

To make the National LGPS Framework for Legal Services as accessible as possible all users are able to access this Framework free of charge but will still benefit from all the usual advantages of using a National LGPS Framework including pre-agreed Terms and Conditions, competitively tendered ceiling prices and supporting documentation
