### Legal Services Framework (re-let)

Launched on 15 Jan 2019



Following on from the success of the previous Legal Services Framework, which expired on 12 January 2019, we have launched the replacement framework.

The new Framework contains 12 service providers across separate Lots for specific types of legal services: Investment, Benefit Administration and Full Service for England and Wales, Scotland and, for the first time, Northern Ireland.

To make using this framework as simple as possible, all users can access this Framework free of charge but still benefit from all the usual advantages of using a National LGPS Framework including pre-agreed T&Cs, competitively tendered ceiling prices and supporting documentation.

Launched in Oct 2018

Building on the very successful and tested collaborative approach used in other National LGPS Frameworks, this multi-user, multi-provider framework helps funds quickly and efficiently source Address Tracing and Correction and Mortality Screening (including Overseas) from a range of providers.

#### Pensions Administration Software Framework Goes Ahead!

The National LGPS Frameworks team have been working with 12 Founding Authorities to assess the viability of setting up a Pensions Administration Software framework in support of the LGPS.

The Founding Authorities include: Cheshire Pension Fund; Clwyd Pension Fund; Essex Pension Fund; Greater Manchester Pension Fund; Merseyside Pension Fund; Norfolk Pension Fund; Northern Ireland Local Government Officers Superannuation Committee (NILGOSC); South Yorkshire Pension Fund; Surrey County Council; Tyne and Wear Pension Fund; West Midlands Pension Fund; and West Yorkshire Pension Fund.

This initiative has the support of central government including MHCLG and Cabinet Office. In addition to the Founding Authorities, there are many funds who have expressed an interest in using the Framework.

Market engagement events have been held to inform potential providers of our intentions and what we hope to achieve, together with exploring the feasibility of a Pensions Administration Software Framework.

Based on the outcome of these activities and the encouraging support from central government, funds and providers, the Founders have decided to proceed with the development of a Pensions Administration Software Framework.

It is currently anticipated that this framework will be available for funds to use within 12 -14 months.
